- a) whether it has engaged in the unconscionable conduct alleged in the House of Representatives on 28 February 2018 by Mr Andrew Wilkie MP.
- b) whether it monitors and probes customers who use its Hume City venues for personal information, and if so:
- c) whether it compiles, stores and/or distributes the private personal information of these customers to other venues; and,
- d) referring to regular gamblers, whether it directs staff at its Hume venues to "be here as much as possible...do whatever you have to do to keep them in the room".
