

- Incorporates best value when spending public money
- > Ensures fairness and transparency for everyone.



How to respond to a procurement opportunity

Some things councils expect from suppliers are not negotiable and must be provided to be considered for council work. If it's requested, you must provide it to avoid being disqualified from evaluation!.

Do's

- ✓ Complete the returnable schedules in full, including:
- ☐ Occupational Health and Safety
- ☐ Insurance
- Quality assurance
- ☐ Tender schedules including pricing
- ✓ Declare any actual or potential conflicts of interest
- ✓ Seek clarification
- ✓ Attend mandatory site inspections


Don'ts

- Approach any member of the Council's staff or Councillors
- × Offer any gifts or hospitality
- × Seek to influence the outcome of the tender process
- × Enter into discussions with other tenderers
- Wait until the closing date and time to submit a response

Please do not contact any member of the Council's staff, Councillors or other tenderers.

Please be patient, await updates and let the process run its course.



Sustainable Procurement

What is sustainable procurement?

Sustainable procurement involves decision making that has the most positive

- Environmental;
- Social; and
- Economic

impacts possible across the entire lifecycle of goods, services and works.



Environmental Sustainability

Council's environmental sustainability approach aims to:

- > Improve energy efficiency;
- > Reduce greenhouse gas emissions and contribution towards Council's carbon footprint;
- Minimise waste production;
- > Improve water efficiency;
- Reduce air, water and soil pollution;
- Reduce biodiversity impacts; and
- > Increase the use of recycled materials to:
- o Reduce demand for raw materials and non-renewable resources; and
- o Close the loop on kerbside recycling.

Social Sustainability




Council's social sustainability approach aims to:

- Ensure suppliers do not exploit workers and ensure they provide fair wages, including inclusive business practices;
- Maintain a social procurement program to increase social procurement spend across Local Business;
- > Ensure sourced products are accessible by all segments of the community;
- Increase employment opportunities for indigenous people, people with a disability, disadvantaged people and long term unemployed;
- > Improve gender equity; and
- > Prevent, detect and remove modern slavery from Council's supply chain.

Economic Sustainability

Council's economic sustainability approach aims to:

- Increase local employment;
- Achieve Value for Money on a whole-of-life (including disposal) basis, rather than just initial cost;
- > Consider broader life cycle impacts of products procured;
- Ensure probity and accountability in the procurement process;
- Commit to sourcing locally; and
- Build relationships with Local Businesses and encourage procurement from them to help build their capacity.



The Municipal Association of Victoria (MAV) is a membership association and the legislated peak body for local government in Victoria.



- MAV Procurement is a not-for-profit unit focused on achieving better procurement outcomes for local government in Victoria.
- MAV primarily establishes and manages panel contracts, where councils can access a wide range of goods and services such as recruitment, digital infrastructure, roads and machinery.
- Currently MAV offers around 30 panel contracts with approximately 200 active suppliers between them.



- Contract MAV / Supplier head agreement
- Council supplier engagement Councils issue RFx's to MAV suppliers through MAV VendorPanel platform and contract directly with them


Overall Program

- All Councils will have an annual capital works program
- Its publicly accessible and can be viewed in each Councils annual budget document
- For the first time this year at Hume we have published a four year capital works program

Capital Program at Hume

- Across the four year program at Hume our annual capital works program is valued at \$153 million
- The program is made up of projects across a variety of categories and project types
- We use a variety of different approaches to procure
 Contractors to complete the work e.g. public tenders,
 selective tenders, request for quote, use of panels etc.

High Level Program - Four Year Program






2024/25 Program

- For 24/25 our capital program is \$154 million
- Its made up of approximately 270 projects and programs
- Values range from projects less than \$500k to projects over \$10 million
- Most projects are spread over multiple years

Summary

- Programs and projects are varied and there are opportunities to undertake work across smaller projects through to larger
