**Hume Galleries Annual Exhibition Program** offers opportunities for emerging and professional artists, first-time exhibitors, hobbyists and community groups to exhibit in our dedicated gallery spaces, supported by the Arts and Culture team.

The program is selected through a competitive Expression of Interest process that encourages innovative exhibitions and projects presented across a broad range of media. We welcome applications for one-off events (e.g. performances, workshops, new and live media) and encourage participation from people under represented in arts including Aboriginal and Torres Strait Islander peoples, LGBTIQA+, Young People, Disability and Culturally Diverse communities.

The annual gallery program is guided by **Hume's Creative Community Strategy** with the aim to building community connection, creating opportunity, fostering wellbeing and belonging through creative expression.

Hume has a substantial Civic Collection of over 8,000 photographs, objects and artworks in addition to independent projects. Council invites submissions that engage with or re-interpret collection items and the opportunity be shown in our dedicated heritage display cabinets located at the Hume Global Learning Centre, Sunbury.

#### The program is open to:

- Hume based artists.
- Hume community groups, including heritage groups wanting to tell local stories in creative ways.
- Artists from outside Hume who can demonstrate a substantial connection to Hume, or propose projects that engage local community members in developing the cultural life of the municipality.

#### **Exhibition logistics:**

The following section outlines key information about the responsibilities held by exhibitors and Hume City Council in relation to the use of the Galleries. Successful applicants will enter a formal exhibition agreement confirming this information.

#### Support offered to exhibitors:

- Free rental.
- Professional assistance from gallery staff and the development, coordination and technical installation of their exhibition.
- Partial staffing of the gallery during opening hours.
- In-kind promotion through Council's promotional avenues.
- Use of supporting infrastructure including lighting, walls, picture frames, AV equipment, plinths and display cabinets.
- Design and distribution of exhibition collateral; e-invites, signage, didactic text and captioning.
- A supported opening event, including light catering, staffing and promotion.

#### **Exhibitor responsibilities:**

- Delivery of the exhibition as proposed in the application.
- Delivery and collection of artworks to and from the gallery (to deadline). Costs for delivery to be met by exhibitor.
- Provision of all promotional, didactic and caption texts for exhibition (to deadline).
- Provision of digital images for promotion, online exhibition and reproduction purposes.
- Assistance with installation and deinstallation of the exhibition as applicable.
- Input into the development of public program activities with gallery staff (e.g. artist talks or workshops – if applicable).
- Observation of best practice Occupational Health and Safety and risk management through the exhibition period.
- Promotion of the project through the exhibitor's networks for maximisation of audience engagement.



#### **Assessment Criteria:**

- Artistic Merit: This category addresses
  the visual and aesthetic qualities of the
  applicant's artwork. It considers the visual
  language used: composition, form, colour,
  and any other qualities important to the
  work, and how these qualities express the
  conceptual ideas behind the artwork.
- **Technical Merit:** This category addresses the applicant's technical skills in their chosen medium. The proposal will be evaluated on how well the applicant demonstrates their abilities with their medium and materials, including attention to detail and their ability to fulfil the proposed exhibition.
- Consideration of the Installation:
   This category assesses the way the applicant has thought through the way their artwork will be installed in their preferred gallery venue: how it will be displayed and consideration of the site.
- Relevance to the Hume Community and Social Justice: This category considers the applicant's connection to the city of Hume and how their work connects to the priorities of the Hume Social Justice Charter.

The program will prioritise first time exhibitors.

#### **Exhibitors are encouraged to:**

- Think creatively about the presentation of their work.
- Provide layout and technical specifications of their work prior to installation.
- Actively participate in the installation process.
- Attend an Information Session.

All applicants are encouraged to **discuss their ideas with our Gallery Curator** before completing their submission.

Additionally, we recommend visiting the **Gee Lee-Wik Doleen Gallery**, the **Town Hall Broadmeadows**, and the **Sunbury Galleries** to familiarize yourself with the exhibition spaces across the municipality.

All final decisions regarding the display of work will be made by the Gallery Curator and Arts and Culture Team.

#### **Exhibition sales:**

Any sale of artworks from an exhibition will be managed entirely by the exhibitor. Hume Galleries do not take commission from fees on artwork sales. On request, gallery staff will connect interested buyers with the exhibitor via email.
