1 POLICY STATEMENT

The provision of compliant sports lighting systems contributes to the continued health, wellbeing and safety of the Hume community by increasing participation in physical activity. The implementation of the proposed upgrade program will ensure that Hume's sport lighting infrastructure meets this objective and remain in good condition and compliance with the required Australian Standards.

2 PURPOSE

This policy outlined criteria and priorities for system upgrades and new installations of sports lighting on Hume sports grounds and facilities.

3 SCOPE

3.1 Categories of Hume Sporting Grounds and Facilities

Hume sporting grounds and facilities are categorised as either Regional, District or Sub-District depending upon the nature of use (competition vs training) and the level of competition being played. Attachment 1 details the category level of each outdoor sporting ground and facility in Hume.

- 3.1.1 Regional Sporting grounds and facilities accommodating state level competition. These are the highest standard of facility in Hume. Examples include Highgate Recreation Reserve AFL Oval 1 and John Ilhan Memorial Reserve Soccer Pitch No.1.
- 3.1.2 District Sporting grounds and facilities accommodating both senior and junior district level competition. The greater proportion of Hume grounds and facilities are classified as district. Examples include Sunbury Recreation Reserve Oval 1 and Laura Douglas Reserve Soccer Pitch 1.
- 3.1.3 Sub-District Sporting grounds and facilities accommodating junior competition and/or senior and junior training only. These facilities will generally only have a single sporting ground and can be utilised by sports clubs for overflow lower grade senior competition. Examples include Bradford Avenue Reserve Oval and Vic Foster Reserve Oval.
- 3.2 Levels of Hume Sports Lighting Provision
 - 3.2.1 The minimum level of lighting provision required at Hume sporting grounds and facilities are:

- 3.2.2 All systems must comply with the minimum lighting uniformity requirements of AS 2560 and minimisation of obtrusive lighting requirements of AS 4282-1997.
- 3.2.3 It is noted that the Northern Suburbs Night Tennis Association (NSNTA) requires tennis courts utilised for night tennis competition to have a maintained 200 lux system rather than the 350 lux identified by AS 2560.
- 3.3 Quantity of Hume Sports Lighting Provision
 - 3.3.1 Council will seek to provide Hume sporting clubs with the following quantities of competition level sports ground and facility lighting at their home reserves:

3.3.2 Consideration will be given to the lighting of additional sporting grounds and facilities for Hume clubs with significant playing membership levels and sustained growth and/or to sporting grounds and facilities that are in poor condition due to overuse.

The Outdoor Sports Lighting Plan has identified a six-year program of works that will implement the Policy. The indicative budget per financial year is based on completing the high, medium and low priorities each over a two-year period.

7 RELATED DOCUMENTS

- 7.1 Australian Standards
 - 7.1.1 There are two Australian Standards regulating the compliance requirements for outdoor sports lighting systems. They are AS 2560 Series and AS 4282-1997 Control of the Obtrusive Effects of Outdoor Lighting.
 - 7.1.2 AS 2560 identifies the minimum requirements for both lux and uniformity of light at sporting grounds. Lux is a measure of the illuminance of the sports lighting while uniformity is a measure of the evenness of the light across the playing area.
