	Presentation 1 – Julia Collin - Community member, Brimbank	6.45pm – 7.25pm

5.	Julia described how community members in Brimbank focused on campaigning with a strong petition. They asked for the Council to develop a Climate Emergency Plan. They drew on the existing resources by CED movement and Julia attributed their success to a strong community movement, Councillor champions and support from Brimbank environment staff. Noted that <i>Hume Horizons and Pathways to Sustainability</i> Council documents are due for renewal, which provides an opportunity for members to advocate for stronger Council commitment on climate emergency. This Taskforce to have input into both of these plans.	

	Cr Jackson suggested a sub-committee group for Taskforce on Climate Emergency might be an option to progress – go through high level documents that we have and look at other Councils and what they might already be doing around the climate emergency issue.
